Cllr. Chislett reported that 2020 had been a very difficult year, and he would like to thank the many parishioners who have volunteered during the pandemic doing various things within the community, to the open spaces committee and the work they have done throughout the year and the parish council for the everything they have done.

Cllr. Westwood thanked Chairman for struggling through ill health to keep things going and to Penny for all she does. Chairman also thanked the Clerk.

Minutes of the Virtual Council meeting of Kenn Parish Council held on Tuesday 13th April at 7pm.

- **3) Declarations Of Interest**: In accordance with the Code of Conduct, members are required to declare any personal or disclosable pecuniary interests, including the nature and extent of such interests they may have, in items to be considered at this meeting. Members are also reminded that any change to their Declaration of Interests must be notified to the Monitoring Officer at Teignbridge District Council within 28 days of the change. None declared.

4) Matters raised by the Chairman (for information)

Another call received reference the litter on the side of the road between Peamore and Kennford which has been in situ for a long time. Referred to the charge points from the last meeting. Cllr. Birt reference to EV charge points. Spoken to a number of different people the general interest is very low, due to a lack of parking already in the village.

5) District and County Councillor Reports –

County Cllr. Connett – a very good visit to Kenn to look for locations for the VAS signs, with the locations noted, received a positive response from Highways.

District Cllr. Nuttall – talked about the connecting Devon & Somerset broadband; areas yet to be finalised but the wards of Kenn are due to be done in the first phase, ie the third quarter of this year. This is the new Airband contract.

7) Open Spaces Committee reports -

- i. Mervyn Hosking to thank Mervyn for his long involvement in the flower boxes around Kenn. Done.
- ii. The Meadow to receive a report from Cllr. Birt benches delivered and installed. Thanks to Cllr. Young for researching and ordering them, to Cllr. Stretton, Chris Connett and Dom Jenks who all helped with the installation. Thanks to Cllr. Taverner who has topped the long grass left from last year.
 - Flower boxes now re-made and mulched. Planting to take place after frosts. Next meeting 19th April.

Cllr. Chislett thanked both Kristen and Chris for all they do for the open spaces.

8) VAS signage for road into Kenn village – to agree next actions and associated expenditure, Cllr. Westwood to move ahead and get quotes for the signage. Cllr. Chislett mentioned CCTV with the possibility of cameras being on the same posts as the signage.

9) Dunchideock Parish – to consider whether Kenn would support a merger with Dunchideock. Cllr. Chislett considered that Kenn Parish Council cannot comment on this possibility as currently there is nothing available to enable this Council to make an informed decision.
