# Minutes of the meeting of Kenn Parish Council held on Tuesday 8<sup>th</sup> June 2021 at 7pm in the Ley Arms, Kenn.

Cllr. Birt as vice chairman took the Chair.

#### 1) PUBLIC DISCUSSION

- **3) Declarations Of Interest**: In accordance with the Code of Conduct, members are required to declare any personal or disclosable pecuniary interests, including the nature and extent of such interests they may have, in items to be considered at this meeting. ### 6) District and County Councillor Reports -

**District Clir. Nuttall** – consultation for the Teignbridge local plan review with the publication of housing sites for consideration. The number of sites far exceeds the need – submit comments on this plan, not just the councillors but members of the public too. Please look carefully at the plans and make suitable comments.

Suggestion of putting together a map to see the implications of the parish – consider how to communicate with residents and encourage them to respond. There is a policies document (Part 1) which came out in 2020 and should be noted with part 2 of this local plan review.

Cllr. Goodey considers that Kenn should work closely with Exminster on this consultation.

Cllr. Diment stated that the amount of land sites seem to be a completely over the top.

Cllr. Nuttall brought up schools and impact on traffic.

The deadline for responses is sometime in August.

Cllr. Goodey read the draft of the revised plan – the population figures are based on the 2011 census. Cllr. Goodey is happy to be a part of a working party on this subject.

Cllr. Taverner commented on Exeter estates and the proposed roundabout.

Cllr. Diment is happy to do some posters regarding communication with residents.

Actions. Clerk to contact Jill Daw, clerk to Exminster. Council could use social media to get the information out.

Consultation starts 14<sup>th</sup> June and all the information will be on the Teignbridge Council website for all to see and access.
