Mrs Helen Mortimer attended the meeting having expressed the desire to join the council, Following the policy of Casual adoption, a discussion was held, the vote was unanimous to co-opt Helen onto the council, filling one of the two vacancies since the May 23 elections. There are still two vacancies following Dom Jinks resignation.

- Public open session, One member of the public spoke about the flooding issues in Kenn Particularly the area around the triangle, pointing out that the culvert under the road is completely silted up and the access overgrown with brambles and other vegetation.
 The issues were taken up under agenda item 23/275,
- **23/271 Minutes of the meeting held on 12**th **September 2023,** The minutes were agreed and signed off by the chairman,

23/272 Matters raised by the Chairman

1, The Chairman reported he had ordered two remembrance wreaths, one for the parish and one for the church, there was some comment on why the church did not source their own wreath. It was agreed that Cllr Stretton and the Clerk would put up the lamp post poppies prior to remembrance day. 2, The recent road works across Gissons lane carried out on behalf of Gissons hotel has started to subside noticeably.

ACTION POINT Clerk to report to Devon Highways and Gissons hotel for action.

3, The interceptor system put in by Highways England when the A38 and the A380 were realigned, does not appear to have been cleared, evidence of pollution is apparent in the river Kenn downstream from the interceptor.

ACTION POINT Clerk to contact Highways England re maintenance the interceptor

4, The desilting of the river bed at Kennford under the bridge has not been done to the usual Standard, in previous years the scrape was down to the ancient, cobbled bed when the river at that point was a ford, the present level will stop the relief flaps the other side of the bridge to be held shut at time of high-water flow.

- VAS signs update on insurance, the councils' insurers confirm that the four VAS signs are covered on the insurance policy.
- 2, Response from highways re HGVs using sat nav's Shillingford lane A reply from Devon Highways confirmed that sat nav nis information is a national problem, DCC is working with South West Freight partnership and other local authorities and encouraging Sat Nav and mapping providers to improve their products
- 3, Horse chestnut tree at Ley arms investigation into the condition of the tree in Kenn suggests the Problem is leaf blotch, coursed by a fungus. Recommendation is to collect fallen leaves and dispose (burn) to atop the fungus spores spreading to new leaf growth in the spring
- 4, DALC Meeting 12th October 6pm clerk will be attending the meeting
- 5, Teignmouth NDP is out for consultation, Cllrs asked to read the policies to see if there is anything that could be used in the KNDP

23/274 District and county councillors' reports,

In the absence of County Councillor Connett, the clerk drew the attention of Council to the DCC

Report sent out by Cllr Connect and circulated to councillors, covering the support available following the recent flooding along with several other topics of interest

District Councillor Nuttall reported that next week is TDCs recycle week, an email was sent out to all Councils asking for support.

Teignbridge District Council is extending for six weeks the consultation into the revised local plan. He confirmed that an affordable housing survey had been sent to all parish and town councils.

District Councillor Lake reported that he had contacted TDC re their tree officer. He confirmed that sandbags supplied by TDC, were intended for domestic household use only. Business's should purchase any sandbags they may require direct from TDC.

Contact had been made to the relevant departments, following enquiries by two residents on Issues overgrown vegetation and the siting of a power pole. TDC contacted regarding litter on the A379, TDC will liaise with DCC to carry out litter picking when highway is being carried out. Cllr Lake also sent supporting emails covering issues the Parish Council were already dealing with, including desilting the river, blocked drains, and double glazing on listed buildings.

District Councillor Parrott Not in attendance

23/275 TO DISCUSS THE RECENT DTORM DAMAGE AND THE EMERGANCY PLAN

The discussion focused on the need for the Emergency plan to be the go-to document for all residents should any emergency occur. The is a need for some updating of content i.e., snow warden helpers. Confirmation regarding access to the sandbag store, and the confirmation that TDC supply the sandbags free of charge for domestic household use, that business's need to purchase sandbags from TDC. The pumps had been checked, storage of fuel is an issue, directions required of where to obtain fuel/in an emergency need to be place with the pumps. Storage of one of the pumps in Kenn could be achieved if the Teign housing project come forward. The issues raised during the public open session were discussed in detail. It was resolved to Approach the land owner of the land bordering the triangle in Kenn for permission to access his land and carryout ditch and culvert clearance, Also investigate the issue of overgrown vegetation in the stream running past Brook cottage.
